From the Executive Director



Certain remarkable shifts happened in the year 2011-12 for FVTRS from the conventional funding role to a facilitation and promotional mode to deepen the cause of skill building taking on board a range of critical players with newer areas, and by entering into basic studies and research on issues connected to the unorganised sector for effective lobbying and advocacy. While the MoU signed with ILO to take forward the cause of entrepreneurship development for emergence of class master trainers was to promote enterprise development, the wide range of research subjects commissioned in the year starting from exclusion issues in the north-east to employment pattern and VT funding allocation in States were some of the relevant topics, along with the completion of the first draft on 'skill watch' based on the unorganised sector perspectives accomplished in the year.

123 vocational training projects were running in the 2011-12 cumulatively where 15452 youth underwent training in 83 trades with a placement rate at more than 70 per cent. The NIOS co-operation has absorbed 1785 school dropout youth who undergo training in VT to make them pass 10th class where 23 out of 38 accredited partners have already made headways.

FVTRS is thankful to all its stakeholders - both internal and outside - who have been extending cooperation in its effort to see the sun. We are very grateful to European Union, ILO New Delhi, NIOS New Delhi for their funding and strategic support to various activities and initiatives, and to Misereor Germany for their co-operation and critical support all through since FVTRS took birth.

The implementing partners of FVTRS has played a crucial role in taking the concerns effectively identifying the focus group and working with them in the interior areas and to them we are very grateful and the various stakeholders who supported at the micro-level. And last but not least to the trainees who underwent training earlier and presently, we are very grateful to all of you. The Board and Advisory Committee of FVTRS have been effectively guiding us regularly and it was this support and cooperation that took FVTRS to new paths. We are very grateful to all of you.

We wish you all the very best and hope to stay connected as ever in the service of the underprivileged youth in an effort to make them employable with a skill.



Promotion of VET/Funding Support

Information on Proposals Received, Approved and Rejected: 2011-12

FVTRS received 259 project proposals during the financial year 2011-12, of which, 69 proposals (27 per cent) were approved while 115 proposals (44 per cent) were rejected after the desk-study done by project team, and 75 proposals (29 per cent) were referred for further study.



Trainees in Approved Projects: 2011-12

In the 69 approved projects supported under Misereor and EU project, 8311 youth are undergoing training among whom 67 per cent are women. More than two-thirds of trainees are women who heavily outnumbered their male counterparts. These VT projects are spread over 19 States comprising north eastern States being supported by the EU project.



As on 31 March 2012, 15452 youth were being trained in various vocational courses of their choice in 123 on-going projects. Women trainees outnumber (61 per cent) their male trainee counterparts (39 per cent) which is close to two-thirds.

Cumulative Information from April 2009




Youth Completed Training: 2011-12

Social Composition of Trained Youth: 2011-12




Placement of Trained Youth: 2011-12






Projects Spread - Region wise Information of Ongoing Projects






VT and Academic Certification Co-operation with NIOS

Realising Dream of Academic Vertical Growth for School Dropout Youth Through the NIOS-FVTRS Collaboration: PASSION

A joint effort of NIOS and FVTRS was initiated in June 2010 with the signing of a MoU to facilitate the trainees undergoing vocational training to complete their studies of class 10th and 12th with the help of flexible courses offered by National Institute of Open Schooling (NIOS). School dropout youth who want to pursue either academic studies or vocational training of their desired trade can obtain a certificate that is recognised both in India and abroad. Partnership of NIOS-FVTRS has fastened the process of accreditation for partner-organisations. FVTRS along with NIOS enabled the concept with a chain of accredited organisations. The cost of enrollment fee was reimbursed to trainees with support from the European Union.

FVTRS makes special support to propagate and promote the cooperation benefits on occasions like partners' meet, promotional consultation meetings, national skill conference, and whenever stakeholders assemble.



At the end of the financial year 2011-12, a total of 1785 youth were enrolled by the accredited institutions: secondary courses (1077), senior secondary courses (128) and in vocational courses (580).

Advocacy and Lobbying for Skill Development

Promotional Consultations

Promotion of employability of school dropout in the unreach regions by roping in committed grass-root organisations across the country

Promotional Consultation (PC) is the regular programme organised by FVTRS with prospective partner-organisations at different parts of the country to sensitise them on the relevance of skill training for school dropout youth. It is a platform where discussions on the subject are held with various stakeholders for collective and collaborative action.

366 representatives from NGOs, skill training providers, civil society, corporates, industries, government departments, academic, financial and educational institutions, and like-minded agencies, media participated in various consultations that were held at Puducherry on 29 June 2011; Siliguri-West Bengal, 27 July 2011; Phulbani-Odisha, 9 August 2011; Jabalpur-Madhya Pradesh, 6 September 2011; Srinagar Jammu & Kashmir, 5 November 2011; Nagpur Maharashtra, 13 January 2012; and at Raichur Karnataka on 15 March 2012.




Reach of Promotional Consultations: 2011-12





Promotional Activities

Topics such as present skill scenario in the country, unorganised sector, need and importance of skill promotion were dealt at the sessions. These consultations were based on the main theme 'Vocational Training (VT) for Employability: Prospects and Challenges in the Unorganized Sector'. Participants were enlightened by inputs from government officials, MFI representatives, and other resource persons' deliberations apart from FVTRS. The occasions were used to identify credible organisations to organise skills training with support from FVTRS and other agencies.



National Jackfruit Fest

Santhigram, a partner organisation from Kerala has organised a three-day 'National Jackfruit Fest-Key to local food security' on 4-6 June 2011 at Thiruvananthapuram, Kerala to promote and propagate jackfruit as a nutritious food, a source of food security and its product diversification. Stakeholders involved in the production and use of jackfruit in the region and all those concerned from Kerala and outside participated. A workshop on jackfruit cultivation, products that could be made from the fruit, its preservation and the required skills were discussed on 27-28 January 2012. Mr CP Nicholas from FVTRS participated in the event.



Meet on Perils of Endosulfan

A meeting with local activists followed by visit to the victims of endosulfan and other pesticides in the districts of Kozhikode and Kasargod of northern Kerala by a team of national level organisations was held at Kasargod on 22 June 2011. It was felt that apart from medical interventions, employment is an issue for the affected victims and people who look after them. Fr Mani Melvettom, Director of Tellicherry Social Service Society coordinated the meet. The team interacted with the district collector and a plan of action was drawn up for future action.



Save A Family Programme

A day long facilitation programme for Save A Family Programme stakeholders was done on 4 August 2011 at Ernakulam. Deliberations focused on livelihood and thrift.

Training Support by SES

A meeting with Senior Experten Services (SES) at Bonn in Germany took place to renew and discuss the services being offered by them in October 2011. In an attempt to enhance partners' efficiency for implementing VT projects, Senior Experten Service (SES), Bonn was contacted to provide training expertise in the areas of business administration, vocational training in business studies, development of curricula and teaching materials and market research, etc. Training programmes for partners has been scheduled for July-August 2012 by Mr Dankward Schoensee.



Regional Market Fair

Trainees introduced to the world of packaging, branding and marketing

Market-Fair provides the opportunity to the trained youth in different trades to showcase their talents through products and art-crafts. The opportunity provides direct interaction with the customers and market players. It gives a sense of recognition, appreciation and confidence on the learnt skills to the trainees. Marketing linkages are simultaneously created for these products. Local government officials, members of local governance, personnel from banks and financial institutions were invited to inaugurate and participate in the fair. Input sessions on the quality of products, packaging, branding, pricing, and marketing were also organised to the benefits of the trainees on the occasion. In 2010-11, three market-fair programmes were organised at Dimapur-Nagaland on 12-13 October 2011; Jodhpur Rajasthan, 21-22 December 2011 and at Raichur-Karnataka on 14-15 March 2012.



HIV/AIDS Awareness in VT Curricula

Ms Ellen Schmitt, Misereor Consultant on HIV/AIDS facilitated the process to develop curricula of vocational training (VT) incorporating HIV/AIDS awareness, addressing the needs of youth engaged in skills training. She visited FVTRS on 5-6 March 2012 to follow-up the process.

Partners' Meet and PIP Meet


Familiarise Partners with FVTRS' Procedures for Effective Project Implementation

A one-day new Partners' Meet and Project Implementation Plan (PIP) workshop is held after project approval to acquaint them with the procedures of project implementation, reporting patterns and formats introduction, documentation, accounting systems, and communication procedures as being practised by FVTRS.



Sessions during the workshops were facilitated by FVTRS staff, orienting new partners on project implementation processes, dealing with the queries and taking feedback to improvise the existing reporting mechanism.

Seven such PIP meets were organised at Hyderabad on 28 April 2011; Guwahati, 6 September 2011 and 5 January 2012; Jabalpur, 8 September 2011; Bangalore, 11 October 2011; Dimapur, 12 October; and Jodhpur, 23 December 2011. Representatives from 85 new partner organisations from 16 States participated.



Skills Training Needs Analysis (STNA) Workshops

The objective of the STNA is to capacitate partner organisations on focus group analysis, trade feasibility, market trends, etc. These events are inaugurated by local government officials, MFIs' representatives and other resource persons who are invited to also conduct sessions on topics on their products and services relevant to skill promotion, trainer selection, trainee retention, entrepreneurship development, need for soft skills, MFI linkages and placement of trainees.





The occasion is used for clarification on the reporting and accounting procedures of FVTRS as well. Four STNA workshops were organised in Puducherry on 30 June 2011, Siliguri-West Bengal on 28 July 2011, Jabalpur-Madhya Pradesh on 7 September 2011 and in Raichur-Karnataka on 13 March 2012.

Training of Trainers (ToT) on EDP

Need-based Customised Training for Partner-Organisations

The Indian counterpart agency of an Australian organisation named Dhanush Infotech was contacted and a meeting with Mr Wil Brakels, Director-Marketing of Datamedu, Hyderabad was held to seek their expertise to train partner organisations of FVTRS on EDP. Following this, a five-day Training of Trainers (ToT) on EDP (Entrepreneurship Development Programme) was held at Lucknow from 22 to 26 August 2011.



23 selected coordinators of the on-going projects attended the programme. It was facilitated by Dr Srujana Kumar, Training & Development Manager and Mr Sai Venkat from DataMedu, Secunderabad. Major topics covered in the training programme were communication for self assessment and steps of improvement, interpersonal skills, knowing one's strengths and weaknesses, identifying driving force in life, time management, understanding stress and its management. As a follow-up, partners started organising EDP training for those who are attending skills training programmes in their projects.



Conventions

Promotion and Facilitation of Enterprise Building

Youth Convention

The objective of Youth Convention is to sensitise the illiterate and school dropout youth on the need of skills training. Topics such as skill deficit situation in the country, unorganised sector, conditions of the unskilled youth, importance of skills training were focused for discussion during the sessions. The occasion was also used to give information on various possibilities of skills training in their areas. Games, songs and exercises are conducted on team work and leadership qualities. Four youth conventions were held during the year 2011-12 at Dimapur-Nagaland on 13 April 2011; Madanapalli Andhra Pradesh on 30 September 2011; Bhopal-Madhya Pradesh on 15 November 2011 and Guwahati-Assam on 29 March 2012.





Bonding with Partners

To strengthen the partnership with existing partners and to discuss the critical issues and areas of project implementation, partners' meetings are organised at various places. National Partners' Meet was held on the sidelines of National Skill Conference at Kolkata on 15 December 2011, attended by 120 partner-organisations, board members and staff of FVTRS. Apart from regular discussions on project plan, activities and challenges faced, partners shared their experiences on best practices. A separate session was conducted for project partners supported by the European Union on the occasion to plan for the future.



Annual Retreat

It was held on 16-17 September 2011 at Bangalore attended by members of General Body, Governing Board, Advisory Committee, partner-organisations and staff of FVTRS. 'Information Education and Communication (IEC) on Skill Education' was the theme. Dr HR Mahadev, Joint Secretary to Chief Minister, Government of Karnataka spoke on the principles of networking with stakeholders, citing examples of his experiences as the representative to government departments. Dr P Basak shared the points of reflections on IEC highlighting the components, types, guidelines, and format of IEC materials required for strengthening the cause and spread of skill education and its dissemination channels by FVTRS and its network. Retreat concluded with a stocktaking and follow-up exercise pursued on previous recommendations with feedback received from the participants.



Founder Memorial Lecture



Founder memorial lecture of Bro Jose Vetticattil, first President of FVTRS was held on 16 September at Bangalore. Mr P Sainath, Rural Affairs Editor, The Hindu delivered the lecture on 'Rural India after two decades of Liberalisation'. Justice Santosh Hegde, Former Lokayukta, Karnataka; Mr P B Mahishi and Dr J Alexander, Former Chief Secretary, Karnataka, and many other dignitaries and officers attended. The programme was presided over by Dr Antony Kariyil, President of FVTRS. Mr Jagadananda, State Information Commissioner (RTI), Odisha; Ms Koely Roy, Vice-President; Board members, partners and staff of FVTRS were also present on the occasion. Participants from different walks of life including students of social work from different educational institutions of Bangalore attended the lecture. **'Rural India has been steadily sliding downhill'** based on the lecture was published in The Hindu, the next day.



Fifth National Skill Conference

The fifth National Skill Conference provided a platform to discuss and deliberate on the practical aspects to translate the concerns into action for the right skill-sets for the unskilled in the unorganised sector

Fifth edition of National Skill Conference was held at Kolkata on 16-17 December 2011. These conferences held since last five years mark the beginning of multi-sectoral approach on issues and emerging concerns of skill deficit designed on the theme of **"Challenges and Opportunities in the Unorganised Sector: All-Encompassing Skills for the Unskilled, Cutting Across All Sectors"**. Stakeholders, decision makers of skill development, skill implementing organisations and agencies got together for active deliberations on various aspects of skill implementation with an all inclusive touch.

Hon. Governor of West Bengal, Mr MK Narayanan inaugurated the two-day conference who conveyed his





message on the prevailing situation of the country pertinent to labour workforce, skill development across the sectors with plausible measures to bridge the gap of knowledge and skill for better economic performance of the nation. Keynote speaker Mr GS Sethi, TVET Consultant & Editor, SKILLS AHEAD emphasised to facilitate today's youth to be educated, trained, and enterprising with right skill-sets to ensure the future of the country. Dr Antony Kariyil, President of FVTRS made a clarion call to all stakeholders to gear up the efforts to skill the unskilled by listening to the present day needs, engaging and supporting the process.



Thematic sessions were presented by speakers on the issues of importance on soft and enterprising skills in the unorganised sector; skill development in agriculture sector and initiatives; available opportunities and scope of improvement in the field of skill development cutting across all the sectors. Aspects like women in the unorganised sector; awareness on HIV/AIDS and need for tailor-made curricula to implement vocational training were part of the conference discussions.

Success Stories

Handholding Support Enables Trainees to be Self Reliant

'Together They Did'

A group of trainees started a production centre with the support of (SIRDS), Koppal, Karnataka where they got training in tailoring course. Organisations like NABARD, UNICEF and local members of the panchayat joined hands with the initiative taken by SIRDS. They succeeded in receiving 50 per cent of interest-free loan from NABARD to start their venture. Trainees arranged the rest of the money by themselves. They got 13 different types of sewing machines at their new production centre at Gunnahalli. They already got some orders from agencies. UNICEF too has been approached for securing new orders.







Partnering with ILO for Enterprise Promotion

The year 2011-12 saw a new cooperation of FVTRS with International Labour Organisation (ILO) emerged for the proliferation of trained master-trainers on Entrepreneurship and Enterprise promotion. The initiative is to address the dearth of EDP (Entrepreneurship Development Programme) trainers and translation of training materials into local languages.

The co-operation was launched during the inaugural programme of National Skill Conference held at Kolkata on 16 December 2011 in the presence of Governor of West Bengal, Shri MK Narayanan. Mr Anandan Menon, Programme Officer, Decent Work Team for South Asia, ILO, New Delhi explained the nature of co-operation while introducing ILO and its agenda of decent work. Training of trainers (ToT) on EDP is the part of SIYB (Start and Improve Your Business) programme that caters to the needs of EDP trainers in vocational training programmes in India, especially in the rural settings.

ILO-FVTRS Co-operation for EDP



Initial phase would be Training of Trainers (ToT) for selected trainers from vocational training partner agencies, followed by organising similar training for the personnel working with the communities by forming a two-member trainer group. Creation of 1200 EDP trainers is the target for the first year of the co-operation. ToT programme would start for the trainers of Uttar Pradesh and Maharashtra. Translation of EDP training materials 'Start Your Business' to Hindi language is being done followed by other languages in the needy States.

The process of co-operation of finalising the terms of co-operation, plan of action, terms of reference (ToR) and Memorandum of Understanding (MoU) were done in a series of meetings with ILO team throughout the year held at New Delhi and Bangalore. Mr Albert Joseph, Executive Director visited the ILO-Geneva office during his trip to Europe in October 2011 and held discussions with the responsible officers. Meetings with Ministry of Labour and Employment (MoLE), Trade Unions, The Employers Federation of India (EFI) were held to strengthen the efforts of enterprise promotion.

Meeting with World Bank and ILO

FVTRS attended the meeting organised on National Vocational Educational Quality Framework (NVEQF) on 3 May 2011 at New Delhi. The effort was to introduce a single value system in educational and vocational training courses to upgrade and standardise quality to integrate vocational education in the academic curricula.

Skilling the Unreached-Appropriate Steps for Skilling the Unorganised Sector

Influencing Policy, discussing strategies at the Donors' and Decision Makers' Meet with Stakeholders



A plan of action with recommendations to strengthen, spread and synchronise skill development initiatives in reaching the unreached youth, and influencing policy to achieve the target of inclusiveness was made at the meeting with key players and skills stakeholders at New Delhi on 15 March 2012. A group of 21 skills players from national and international NGOs, DGET, GIZ, NIESBUD, NIOS, CL Educate, EU delegates in India, IRIS, World Bank, ILO, a Rajya Sabha member were gathered to discuss on the issue of skill, identify gaps in skill approach and to derive strategies to reach the unreached. Dr Cherian Joseph, HR consultant and Ms Anita Sharma, Senior Programme Officer, GIZ facilitated the meet.

What need to be done?

- Efforts to collective and summarise individual contributions towards skill intervention into substantive impact
- Efforts to changes at policy and direction in achieving the national goal of skilling 500 million people by 2022
- Efforts to form appropriate policy formulations

- Efforts to explore new areas of training, changing structure and level of training, enhancing funds availability, mapping vocational training providers, filling information gap, NGOs' networking and coordination
- Strategic paper preparation to seek cooperation and support from the government and other agencies as well as to get donor contribution
- Efforts to upgrade skills of manual labourers like scavengers and etc
- Training should be planned in association with social values and binding with the existing value system
Focused and quality skills training
- Skills and work opportunity for rural youth
- Dignity of labour in cases of migration
- Ease of grant and fund to small NGOs working at grass roots
- Promoting self employment by successful skill training models
- More and more doers in the field of skill development

Consortium Meet

Mr Albert Joseph, Executive Director visited Europe in October 2011 to meet Eurecna Consortium members and to submit the project proposal to EU. He met Mr Andrea Badalamenti, Project Manager-International Relations, Formaper (Italian Chamber of Commerce and Industry) in Milan exploring funding possibilities for skill training and for setting up a skill training centre at Bangalore.



Research, Study and Documentation

Research Projects

During the year, four projects on research and study were supported in the States of Odisha (two projects), Uttar Pradesh (one project), and in Uttarakhand (one project). Research projects were started in three regions of north, north-east and south under EU-supported project. Three researchers were selected by inviting applications for project proposals with MoU signed between the researchers and FVTRS.

Topics of the research are 'Resource Allocation for VET by State and Central Government' in the south India, 'Employment Pattern' in the north India and 'Exclusion issues in northeastern States' in north-east region. The project would be completed by the end of September 2012 with the publication of the reports.



Earlier in the year on 18 September 2011, a one-day workshop was facilitated by Dr Ghandi Doss, Advisory Committee Member, FVTRS in Bangalore for the applicants to understand research policy guidelines evolved by FVTRS and to familiarise them on details of the methodologies to fine-tune the submitted proposals.

Miscellaneous

Skill-Watch

Skill Watch, a research paper of FVTRS highlighting the features of the unorganised sector was documented by Dr P Basak, Board Member of FVTRS.

Documentary Films

Four short documentary films named: 'We Made it', 'The Unbranded', 'Beat to Beat' and 'Excluded with Dignity' are released. The films are about the best practices and studies in various regions. The Hindi version of the previous documentary film '**Not Born to Burn**' was done in the year.

IEC Publications

During the National Skill Conference FVTRS published English Brochure, Calendars and Souvenir. The first Skill Watch Annual is ready and the second one is under preparation. A brochure has been published in Assamese language in March, 2012. This has been circulated among partner organisations and other stakeholders in the eastern region. The same brochure has been translated into Tamil, Telugu and Kannada for the southern region.

Annual Report, quarterly News Bulletins, latest FVTRS brochure, reports and documentation of various events and programmes were distributed (hardcopy and in CDs) among partners and stakeholders.

Employment Facilitation Cell

Job placement is one of the dynamics of the skill training. During the training period, the service providers pay special attention on the placement of trainees. Necessary links/contacts are established with various types of employers/industries for employment. Similarly linkages with micro-finance institutions, local banks and government schemes are established for the self-employment of trainees. The regional offices and all FVTRS service providers facilitate the process of employment at regular intervals.

Setting Up A Resource Database

A centralised database has been created by FVTRS. The regional offices collect relevant region-specific data for the database regularly. Apart from this, there is an 'Internal Monitoring System' where all the events and activities are updated in the online database.

'A Plumber is as Important as a Doctor' by Mr Albert Joseph, Executive Director, FVTRS was published in The Hindu on 22 May 2011 in the Open Page on the core issue of skill development.

A plumber is as important as a doctor

Albert Joseph

India is a skill deficit nation where 12 per cent of its population is skilled and only two per cent receive any formal skill training in any employable trade. A young nation with 52 per cent of its population aged below 25 years and where 88 per cent school dropout rate exists, one can only imagine the way they are deprived of a dignified life for no fault of theirs. With June 2011 projected as the month when the seven billionth child will be born in India, it is going to be the illiteracy capital of the world along with other undesirable indices on many other fronts.

The first window in the life of a young person is the school and that is shut to them for reasons of access, poverty and tradition as planners put it. The second

window that could be opened in the lives of young people is through a 'skill window' which has a dignity, equaliser and currency role as the person takes on in life.

There is no perceptible effort done at the lower educational level to sensitise and orient the young understand that it is a stigma that prevents them from entering the 'skill world' and thus save them from the aimless pursuit of higher education. The myth and greatness attached to professional courses could be broken only with purposeful efforts from parents and at school level in today's highly polarised and diversified world. Only 25 per cent is employable out of the six lakh engineers who come out every year is a sad pointer in this context.

Thus stigmatised, India's 9,000 ITIs and polytechnics

with 10 lakh seating capacity can only expect students to enter these premises with a frustrated mindset, as being not otherwise useful. Australia, where this stigma existed 15 years ago, is now rid of it. A plumber is the most sought after person there than a medical doctor.

A recent incident in London showed that an Indian medical doctor changed his profession to plumbing, realising that a plumber there earns much more. China has started giving Ph.D. for plumbers who excel in their line of work. Are these jobs not dignified enough? The celebration of skilled manpower has to be the order of the day as we celebrate people who sing well, dance and act. Everything done well contributes to the growth of the comfort that we enjoy as like an electrician, carpenter, driver or

sweeper without whom no life is possible.

The archaic teaching curricula in the ITIs, poor infrastructure, and the fossilised teaching methods will become a thing of the past if young dedicated minds start entering these premises and the governance feels the heat to improvise the infrastructure, curricula and expertise. Proportionate improvement of enrolment and services will be felt vertically and laterally at all erstwhile defunct institutional levels.

For that to happen a 'skill movement' should take place from school education and at plus-two level onwards..

Governing Board and Project Selection Committee Meetings

In 2011-12, Annual General Body Meeting (AGBM) and four Governing Board meetings along with four PSC (Project Selection Committee) meetings were held to take stock of the activities, approval of programme plan and budget and project proposals.

Important decisions took place during the AGBM are:

- 30 per cent of the budget may be reserved for agriculture sector-based trades
- More of women friendly trades to be identified
- 5 per cent of the budget shall be dedicated for innovative trades
- Data on differently-abled persons who are trainees to be shown separately
- Invite lead bank managers while organising EDP training to discuss on hurdles involved in enterprise development and bank loan matters
- Additional effort to be taken up for getting more research and study proposals
- A social audit on projects to be carried out
- FVTRS should reform as a 'Centre of Excellence' while promoting the cause of vocational training
- NIOS affiliated courses and the institutions to be added with their addresses in the annual report
- RTE act and its benefits to be communicated as and when possible while organising various programmes
- Support more of multi-skill and teachers' training

Project Selection Committee (PSC) approved a total of 69 project proposals for an account of Rs. 3.43 crore during the financial year. Proposed number of trainees is 8311 (inclusive of 5535 women and 2776 men) for vocational training programmes in 56 trades spread over to 19 States across the country.

A plot of land measuring 1720 sq. ft has been bought at Hedge Nagar, Bangalore to set up the office and training centre.

Project Implementation and Monitoring

Improvise Monitoring Mechanism and Prioritise Capacity Needs to Smoothen Existing Project Implementation System

FVTRS has strengthened and updated its project approval processes, monitoring and evaluation mechanisms by reviewing the present system with the help of Dr Joseph Sebastian, Director, IGSSS, New Delhi and the member of FVTRS' Board. He facilitated the reviewing process by analysing the existing monitoring system with the team of FVTRS in an effort to improvise it. New guidelines on the selection criteria of received project proposals, pre assessment visits, project monitoring mechanisms and reporting formats were discussed and finalised for follow-up.

A new line item was created for the promotion of academic vertical growth of 1375 school dropout trainees for NIOS certification. The revised budget was approved by the EU delegation in June 2011.


